The Islamic Republic of Pakistan through Government of the Punjab / Rawalpindi Development Authority (RDA) intends to construct Rawalpindi Ring Road (R3 Project) to meet futuristic growth and mitigate the traffic congestion issues/ constraints coupled with economic corridor capacity. Different routes alignments as already suggested/approved in the recent years. Now RDA through PMU intends to hire services of Consulting Firm for:

Third Party Validation Consultant for determination of Optimal Route for Rawalpindi Ring Road Economic Corridor (R3 Project) (Estimated Cost PKR. 30.00 Million)

Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. Expressions of Interest (EOI) are invited under PPRA Rule 2014 (Local Procurement rules). The interested consultancy firms having experience of similar nature works may apply for selection alongwith the following information / particulars, duly supported with necessary documents:

1. Name of firm / address of the registered office with telephone / fax number and e-mail address including organization chart showing management structure. In case of JV, provide information of all JV members.
2. Firm(s)/ joint venture(s) name, address, copy of the Registration Certificates with relevant professional bodies of the concerned regulatory bodies/authority of the origin country.
3. Company profile, ownership and organizational structure of the consultant/ Joint Venture.
4. Audit Statement of account for the previous 03-years including the Audited Balance Sheet and Profit & Loss Account of the Bidder (of each member in case of a consortium).
5. Firm or in case of JV/association/consortium, details of net worth 100 million in PKR, Annual average turnover of Rs. 200 million in PKR dully filled and signed.
6. Maximum three (03) numbers of firms are allowed to make JV / consortium. The same firm shall not be allowed to submit RFP individually and in JV with any other firm. For international firms, it is mandatory to make JV / consortium with local firm/firms.
7. Any firm either individual or joint venture partner or any person employee of firm involved / participated directly or indirectly in design and review of R3 Project shall not eligible to participate in TPV directly/ indirectly, as a JV partner or individually.
8. All the Consultants are allowed to participate in the subject procurement without regard to nationality, except Consultants of some nationality, prohibited in accordance with policy of the Government. Ministry of Interior, Government of Pakistan has notified List of Business Friendly Countries (BVL), Latest information may be confirmed from the relevant quarter or from the website <https://visa.nadra.gov.pk/business-visa-list-bvl/>.

Interested firms may obtain Pre-Qualification Documents (PQD), on request from the office of Deputy Project Director, Project Management Unit, Commissioner's Office, Katchehry Chowk, Rawalpindi by paying of Rs. 2000/- in RDA Account.
