RDA Task Force conducts stringent action against legal, illegal housing societies.

Task Force conducts grand operation against 3 housing schemes, one approved housing scheme Gulshan-e-Abad's illegal construction and 2 illegal housing schemes Royal Marina City and Multi garden Phase-II, demolishes site offices, bunker, boundary walls, road infrastructure, and entrance barrier.

RAWALPINDI, November 14, 2023: As per the Divisional Intelligence Committee meeting, the Task Force's operations are continue. Task Force has conducted a grand operation against three housing schemes, one approved housing scheme Gulshan-e-Abad's illegal construction at mouza Kalyal and Kalri Morgah and two illegal housing scheme namely Royal Marina City at mouza Dhok Abdullah and Multi Garden Phase-II at mouza Chahan Rawalpindi and demolished site offices, bunker, boundary walls, road infrastructure, and entrance barrier, RDA spokesperson said.

He said on the directions of the Commissioner Rawalpindi Division Liaqat Ali Chattha, the DG RDA, the DC Rawalpindi and CPO Rawalpindi are supervising operations against illegal housing societies.

The DG RDA Muhammad Saif Anwar Jappa said that on the instructions of the Commissioner Rawalpindi, grand operations against all illegal societies will be continue across the board to stop fraud of illegal housing schemes and looting of the citizens.

He said that complaints were received from the general public about illegal occupation of the owners of illegal housing schemes. Strict actions will be taken against those who take possession of land by force of arms.

He said that the owners of the housing schemes who have completed the legal documents have been given the possession of the land. The RDA has been issuing press releases from time to time for the information of the general public. The citizens should not invest in illegal housing schemes and requested to visit RDA website www.rda.gop.pk and advised to buy and sell only from approved housing schemes.

According to the authorities, previously notices were issued to the owners and sponsors of above mentioned housing schemes to stop illegal advertisements, bookings and development.

The owners of these properties were running booking offices of illegal housing schemes in violation of the rules.

The operation team including Muhammad Usman Bajwa, Assistant Director Building Control RDA, Mehwish Naseem Assistant Director Planning, with police team from Police Stations Saddar Beroni and Chontra Rawalpindi, RDA Scheme/Building Inspectors, District Council Inspector, District Administration Representative along with other team members taken grand operation jointly.
