ADOPTION OF LDA BUILDING ZONING REGULATIONS, 2019 (RDA BUILDING AND ZONING REGULATIONS, 2019)

Director (LU&BC), RDA briefed that orders from the Secretary HUD & PHED, Govt of the Punjab along with the copy of LDA Building & Zoning Regulations 2019 received for adoption vide letter No.SO(H-II)3-2/2016 dated 29th November, 2019. The LDA Building & Zoning Regulations, 2019 have been gone through in detail. After few amendments in LDA Building and Zoning Regulations, 2019, RDA Building & Zoning Regulations, 2019 were submitted before the Governing Body for getting approval of adoption of these rules to the extent which are general in nature except of those which are specifically related to Lahore only. These Regulations shall be applicable from the date of approval of the Governing Body of the Authority.

## JURISDICTION, PP-12 & PP-13 (UC-76 TO UC-93)

It was briefed by Managing Director WASA that WASA does not have enough resources to efficiently run the water supply system in PP-12 & 13 which was included in the jurisdiction of WASA in 2013. The local representative of PP-12 & 13 are also demanding to hand over said schemes to CBOs for efficient O&M. It was requested to recommend de-notification of the said area from WASA service jurisdiction so that case shall be forwarded to Chief Minister for approval. The Authority agreed with the proposals of Managing Director, WASA.

- 4. It was unanimously decided that the meeting of Governing Body of Rawalpindi Development Authority will be conducted once a month. The next date of convening the meeting of Governing Body of RDA was fixed as 25.01.2020.
