DELEGATION OF POWERS

DIRECTOR ENGINEERING

To transfer employees below BPS-11 within the Directorate.

To exercise appellate powers against the orders of Deputy Director.

To suspend employees in BPS-10 and below working under the control of Director Engineering and order departmental enquiry against them.

To accord technical sanction in the case of original works, upto 10% over the amount of the administrative approval, and within the following financial limits:-

- (a) Director Conmikrootimi (Roads) Rs.50 lac.
- (b) Director Consproelion (Buildings) Rs.25 lac.
- (c) Director (Planning & Design) Rs.25 lac.

To accord technical sanction in the case of ordinary and special repairs of office and residential buildings, and of roads, within the following financial limits:-

(a) Director (Buildings) Office Buildings Rs.2,50,000/-

(b) Director (Buildings) Residential Buildings Rs. 2,000/- (per building)

(c) Director (Roads) Roads: Rs.5, 00,000/-

To accept tenders upto Rs.50 lacs in the case of Director (Roads) and Rs.25 lacs in the case of Director (Buildings) subject to the conditions that first the normal procedure laid down for invitation of tenders has been followed; secondly, the rates quoted and/or amount tendered are such that the total cost of a project/work does not exceed the mount for which the project/work has been administratively; approved by more than 10%; and third, where the lowest tender is not accepted, reasons are recorded and further approval of the Chief Engineer obtained in the case of tenders upto the value of Rs.5 lacs, and the Director General in case of tenders above Rs.5 lacs.

To make appointments, subject to approval of Director General, of work-charged staff in BPS-10 and below subject to the conditions that, first, provision exists in the sanctioned estimates; secondly, the power is exercised only when the order to commence the work has been received; third, services of work-charged staff are terminated as soon as work is completed; and

fourth, the pay allowed does not exceed that allowed to regular establishment of the same category.

To sanction expenditure, subject to budget provision, on purchase of tools and plant, other than vehicles and imported tools and plant, upto Rs.10,000/-.

To sanction expenditure on repairs and carriage of tools and plant upto Rs. 10,000/-.

To sanction expenditure on local purchase of stationery upto Rs.500/- per annum.

To sanction expenditure on repairs of instruments and furniture upto Rs.4, 000/- per annum.

To sanction expenditure on hire of furniture upto Rs.4, 000/- per annum.

To sanction expenditure in emergent cases, on account of binding work executed locally upto Rs.500/- per annum.

To sanction expenditure on carriage of record.

To sanction expenditure on freight for movement of RDA properties upto Rs.3,000/- at a time.

To sanction Hot and Cold weather charges subject to such directions as the Director General may give for the Judicious exercise of this power.

To declare stores surplus or unserviceable upto the value of Rs.50,000/- at a time, the value to be original Book Value.

To incur expenditure out of the imprest amount placed, at his disposal subject to the provision that expenditure on any particular item does not exceed Rs.100/- at a time.

To sanction annual leave to officers/officials working in the Engineering Directorate.
