In the backdrop of multiple complaints dully filed by the residents and affected allottees / members of University Town (UT), Rawalpindi, on various forums including to the Secretary Housing, Urban Development and Public Health Engineering Department, Lahore against the serious violations committed by the developer, M/s University Town Rawalpindi, M/s Haji Aziz Khan, Mr Jameel Khan and their accomplice Mr. Asad-Ullah Ata (referred as Developer / Sponsor of University Town Pvt Ltd) from past three decades, the Secretary, HUD & PHE, Govt. of the Punjab, Lahore while taking cognizance of the issue passed executive orders to take serious action against the Management of University Town, including but not limited to blockage of NICs, put their names on Exit Control List and take strict action to monitor the financial transactions of M/S University Town and put a comprehensive inquiry report to the higher authorities.
